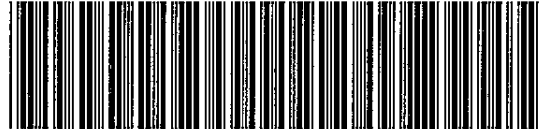

1. The name of the Corporation is: SEK-TER, INC.
2. Article I of the Articles of Incorporation of the Corporation is hereby amended to read as follows:

ARTICLE I

NAME

The name of the Corporation is TEMPEST CYCLES, INC. (hereinafter called the "Corporation").

3.
