ARTICLES OF ORGANIZATION

OF

ADKINS PROPERTIES, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes, Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I: Name

The name of the limited liability company shall be Adkins Properties, LLC (the "Company"). The mailing and street address of the principal office of the Company in Florida shall be 2338 Cheryl Drive, Jacksonville, Florida 32217-3566.

ARTICLE II: Duration

The Company's existence shall commence on the date these Articles of Organization are filed by the Florida Department of State and shall continue perpetually or until dissolved in accordance with these Articles of Organization adopted by the members.

ARTICLE III: Purposes and Powers

The general purpose for which this Company is organized is to transact any lawful business for which a limited liability company may be organized under the laws of the State of Florida. Each member shall make capital contributions to the Company only upon the unanimous consent of all the members.

No additional members shall be admitted to the Company except with the unanimous written consent of the members of the Company.

The managers shall hold the offices and have the responsibilities accorded to them by the members as set out in the Operating Agreement.
