# AMENDED AND RESTATED ARTICLES OF INCORPORATION OF THE PAMSCO GROUP, INC.



Pursuant to Section 607.1007, Florida Statutes, the Board of Directors and Shareholders of THE PAMSCO GROUP, INC., a corporation duly organized and existing under the laws of the State of Florida (the "Corporation), having executed a Written Consent in Lieu of Special Meeting of the Board of Directors and Shareholders pursuant to Sections 607.0704 and 607.0821, Florida Statutes, do hereby adopt the following Amended and Restated Articles of Incorporation as follows:

#### **ARTICLE I**

The name of this Corporation is: THE PAMSCO GROUP, INC.

#### ARTICLEII

The Corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida. While engaging in such activity or business, it may exercise all of the powers and privileges conferred by the Florida General Corporations Act as presently in effect and as it may be amended from time to time in the future.

#### **ARTICLE III**

The aggregate number of shares which the Corporation shall have the authority to issue shall be 10,000 common shares at \$1.00 par value.

Property, but not labor or services, may be purchased or paid for with the capital stock at a just valuation to be fixed by the Board of Directors at a meeting called for that purpose.


