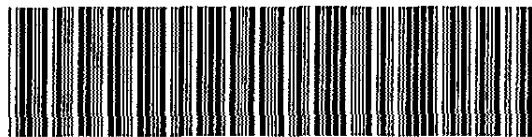

OF

Corporation for Profit under Florida Law.

The names and street addresses of the initial directors who shall hold office until their successors are elected and have qualified are as follows:

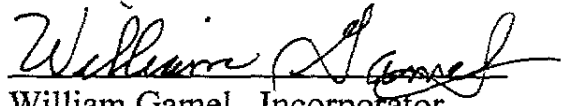

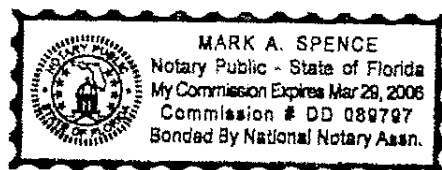
