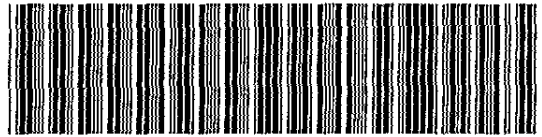

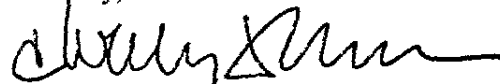

**ARTICLES OF ORGANIZATION OF
INTENDE SOLUTIONS, LLC**

The undersigned, desiring to form a Limited Liability Company under and pursuant to §608.405, Florida Statutes, does hereby certify as follows:

FIRST: The name of said limited liability company shall be INTENDE SOLUTIONS, LLC.

SECOND: INTENDE SOLUTIONS, LLC shall exist in perpetuity.

THIRD: Copies of the Operating Agreement of INTENDE SOLUTIONS, LLC may be obtained from the Manager at 10230 SW 109 Street, Miami, FL 33176 which is the place in the State of Florida where the principal office of the limited liability company is located. The mailing address of INTENDE SOLUTIONS, LLC shall be 10230 SW 109 Street, Miami, FL 33176.

FOURTH: The purposes for which INTENDE SOLUTIONS, LLC is formed are:

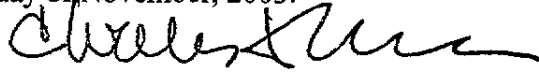

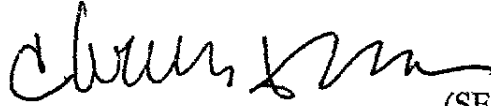
