The undersigned, being not less than two-thirds of all of the mobile home owners of <u>Lakeside Village Mobile Home Park</u>, for the purpose of forming a nonprofit corporation under Florida Statutes Chapter 723 and 617 and 617 do hereby make and adopt the following Articles of Incorporation.

#### Article I.

The name of the corporation is:

- (f) To conduct Bingo Games, as provided in Chapter 849.093, Florida Statues, or its successor Statues.

### ARTICLE IV DURATION AND TIME DATE OF COMMENCEMENT

The duration of the Corporation is perpetual, and the Corporation shall commence at the time and date of filing of these Articles with the Secretary of State,

### ARTICLE V. LIMITATION

No part of the net earnings of the Corporation shall inure to the benefit of or be distributable to its Members, trustees or Officers, but the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III (Purposes) hereof.

### ARTICLE VI. MEMBERS
