ARTICLE I - NAME

The name of this Corporation is J & C Home Services, Inc. and the physical address is 26443 Sleepy Hollow Street, Mt. Plymouth, 32776 with a mailing address of P. O. Box 1473, Sorrento, Florida 32776.

ARTICLE II - TERM OF EXISTENCE

The existence of this Corporation shall exist perpetually.

ARTICLE III - NATURE OF BUSINESS

These Articles of Incorporation may be amended only by the vote or written consent of the holder of seventy-five percent (75%) of the outstanding shares entitled to vote.

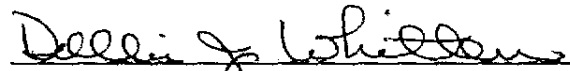
