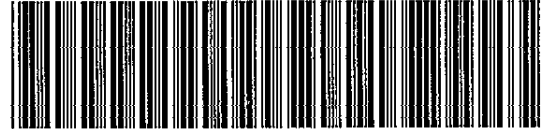

Article VI: Directors

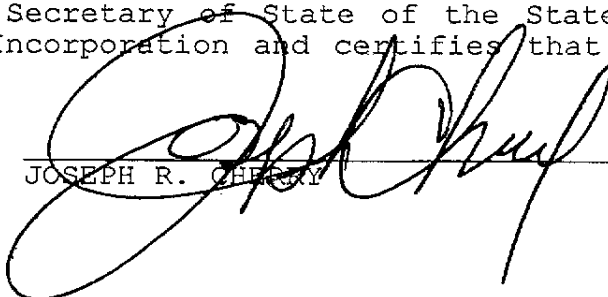
The business of this corporation shall be managed by the stockholders of the corporation, rather than by a Board of Directors.
