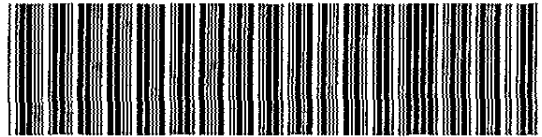

ARTICLE I

NAME AND PRINCIPAL PLACE OF BUSINESS

The name of this limited liability company shall be NANCY L. COLE-REAMES PAINTING, LLC, and the mailing address and street address of its principal office shall be 10307 S.W. Lettuce Lake, PM #14, Arcadia, Florida 34269, but it shall have the power and authority to establish branch offices at any other place or places as the members may designate.

ARTICLE II
