

We have received and filed your application for renewal of your State-Issued Certificate of Franchise Authority for cable and/or video service. The Federal Communication Commission's Cable Act Reform 47 C.F.R. 76.952 states that "all cable operators must provide to the subscribers the name, mailing address and phone number of the franchising authority, unless the franchising authority in writing request that cable operator to omit such information."
