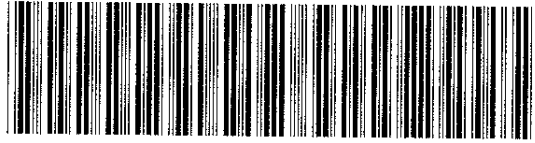

Consistent with our desire to keep you fully informed regarding the activities that relate to the cable service provided in Florida, we are amending the name of a legal entity operating in various service areas as described in Attachment A of the Application.
