

Knology, Inc., on behalf of itself and its subsidiaries, Knology Broadband of Florida, Inc. and Knology of Florida, Inc., (collectively "Knology") applied for and received a state issued Certificate of Franchise Authority to provide cable and/or video service in specified areas in Florida. Specifically, Knology was granted authority to provide service in Bay County, Florida, as well as the cities of Dunedin, Tarpon Springs, Seminole, Oldsmar and Largo, Florida. 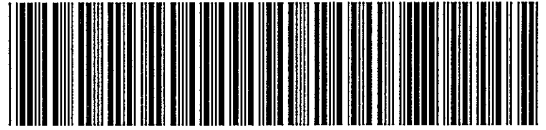
