AFFIDAVIT

- I, <u>Chad S. Wachter</u>, am employed with Knology, Inc. in an official capacity as the <u>Vice President and General Counsel</u> and do hereby attest to the facts stated herein from my personal knowledge. I hereby swear and affirm that the following statements are true and correct:
 - 1. Knology, Inc. files its application for a state issued certificate of franchise authority on behalf of itself and its subsidiaries, Knology Broadband of Florida, Inc. and Knology of Florida, Inc., hereinafter collectively referred to as "Knology."
 - 2. Knology is fully qualified under the provisions of this Chapter 610, F.S., to file an application and affidavit for a certificate of franchise authority.
 - 3. Knology has filed with the Federal Communications Commission all forms required by that agency in advance of offering cable or video service in the state of Florida.
 - 4. Knology agrees to comply with all applicable federal and state laws and regulations, to the extent such state laws and rules are not in conflict with or superseded by the provision of Chapter 610, F.S., or other applicable state law.
 - 5. Knology agrees to comply with all state laws and rules and municipal and county ordinances and regulation regarding the placement and maintenance of communications facilities in the public right-of-way that are generally applicable to providers of communications services in accordance with s. 337.401, F.S.
 - 6. Knology is seeking a certificate of franchise authority for the following service area, consistent with s. 610.104(2)(e) 5a & b, F.S.;
 - a. The area consisting of the corporate limits of the City of Dunedin, Florida, as its border may be changed from time to time. This area is currently being served by Knology Broadband of Florida, Inc. under a franchise agreement with the City of Dunedin. The entity providing service in this area under the state issued certificate of franchise authority shall be Knology Broadband of Florida, Inc.
 - b. All unincorporated areas of Bay County, Florida. This area is currently being served by Knology of Florida, Inc. under a license issued by the Board of County Commissioners of Bay County, Florida. The entity providing service in this area under the state issued certificate of franchise authority shall be Knology of Florida, Inc.

- c. The area consisting of the corporate limits of the City of Seminole, Florida, as its border may be changed from time to time. The area is currently being served by Knology Broadband of Florida, Inc. under a franchise agreement with the City of Seminole. The entity providing service in this area under the state issued certificate of franchise authority shall be Knology Broadband of Florida, Inc.
- d. The area consisting of the corporate limits of the City of Tarpon Springs, Florida, as its border may be changed from time to time. The area is currently being served by Knology Broadband of Florida, Inc. under a franchise agreement with the City of Tarpon Springs. The entity providing service in this area under the state issued certificate of franchise authority shall be Knology Broadband of Florida, Inc.
- e. The area consisting of the corporate limits of the City of Largo, Florida, as its border may be changed from time to time. The area is currently being served by Knology Broadband of Florida, Inc. under a franchise agreement with the City of Largo. The entity providing service in this area under the state issued certificate of franchise authority shall be Knology Broadband of Florida, Inc.
