DEPARTMENT'S FIRST SET OF INTERROGATORIES

The Department of State (the "Department"), pursuant to Section 607.0130(1), Florida Statutes, propounds the following interrogatories to be answered within thirty days as provided in the applicable statute.

DEFINITIONS

1. As used herein, "you", "yours" and "your" means, David Nepo, his agents, representatives, employees, and any persons or entities acting on behalf of David Nepo.
2. As used herein, "document" or "documents" includes all originals, copies, and drafts of any written typewritten, recorded, transcribed, printed, taped, photographic, or graphic matter, however produced or reproduced, whether sent or received, or neither, including but not limited to, all reports, memorandum, letters, minutes, correspondence, notes, notebooks, manuals, books, brochures, lists, publications, periodicals, computer printouts, printed forms, drawings, sketches, maps, graphs, charts, photographs, films, tapes, and other writings, or data compilations of any kind from which information can be obtained.

3. As used herein, "identify" or "identity of" means: (1) when used with respect to a person, to state the person's full name, present or last known business and residential addresses, and present or last known employer and position; (2) when used with respect to a document, to describe the document by character (e.g., letter, report, memorandum, etc.), author, date, and to state its present location and custodian; (3) when used with respect to an oral communication, to identify the persons making and receiving the communication, the approximate date and time of the of the communication, and a summary of its content or substance.

4. As used herein, "relating to" means concerning, respecting, referring to, summarizing, digesting, embodying, reflecting, establishing, tending to establish, evidencing, comprising, connected with, commenting on, responding to, disagreeing with, showing, describing, analyzing, or representing.

INTERROGATORIES;

1. State the name(s) and address (es) of all persons who are believed by you, your agents or attorneys, to have any knowledge of any of the issues relating to your entitlement to serve as an officer or director of Florida Coast Line Canal and Transportation Company and specify the subject matter about which each witness has knowledge.

2. State each and every fact which supports your contention or representation to the Department that you are entitled to serve as an officer or director of Florida Coast Line Canal and Transportation Company. Please attach to this response any documents tending to support your contention or representation to the Department that you are entitled to serve as an officer or director of Florida Coast Line Canal and Transportation Company.

3. Identify, as identify is defined herein, any and all fact witnesses that you expect would substantiate your contention or representation to the Department that you are entitled to serve as an officer or director of Florida Coast Line Canal and Transportation Company.

4. For each fact witness identified in Interrogatory # 3 above, state the subject matter about which the witness is expected to testify.

5. State the name and address of all persons who have answered or contributed to answering any of the interrogatories set forth above.
