ARTICLES OF AMENDMENT  
TO  
ARTICLES OF INCORPORATION  
OF  
GULF TRADING OF CARRABELLE, INC.

Pursuant to the provisions of Florida Law of 1905 and Florida Statutes, section 607.1006, this Florida profit corporation adopts the following articles of amendment to its articles of incorporation:

FIRST: Amendment adopted: *Corporation No. 93000*

The shareholders of Gulf Trading of Carrabelle, Inc. voted unanimously, May 16, 1998, as follows:

Article 4, of the charter, reads as follows: The term for which said corporation shall exist shall be ninty nine years,

Remove the words ninty nine years and insert the word perpetuity. to read, The term for which said corporation shall exist shall be perpetuity.
