Pursuant to the provisions of section 607.1006, Florida Statutes, the Florida Profit Corporation adopts the following amendment to its Articles of Incorporation:

NEW CORPORATE NAME:

Lainhart and Potter, Inc.

AMENDMENTS ADOPTED:

ARTICLE THREE of the existing Articles of Incorporation, filed July 15, 1919, is hereby amended by deleting the existing ARTICLE THREE in its entirety and restating it as follows:

ARTICLE THREE

The maximum number of shares of capital stock that the Corporation is authorized to issue and have outstanding at any one time is Five Hundred Thousand (500,000) shares of common stock having a par value of Ten Cents (\$.10) per share.

This amendment shall be implemented through an exchange of shares pursuant a recapitalization agreement to be executed by the shareholders hereafter.
