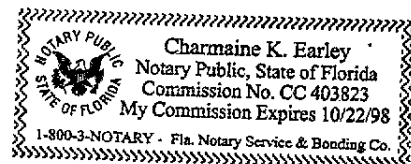

I.

The name of the corporation is St. Joseph Telephone & Telegraph Company (the "Corporation").

II.

Article I of the Articles of Incorporation of the Corporation is hereby amended as follows:

ARTICLE I - NAME

The name of the Corporation is GTC, Inc. (hereinafter called the "Corporation").

III.

This Amendment was adopted pursuant to Sections 607.0824 and 607.0704 of the Florida Business Corporation Act by resolution of the board of directors as of October 1, 1997, and by written consent of the sole shareholder of the Corporation as of October 1, 1997, and the number of votes cast for the amendment by the shareholder was sufficient for approval.
