ARTICLES OF AMENDMENT TO CHARTER OF WEWAHITCHKA STATE BANK

FILED SECRETARY OF STAIL DIVISION OF CORPORATIONS

2003 MAY 23 AM II: 59

Pursuant to Section 607.1006, Florida Statutes, the Charter, which constitutes the Articles of Incorporation, of Wewahitchka State Bank, a Florida banking corporation, is hereby amended as follows:

FIRST:

Article I of the Charter is hereby amended by deleting the text thereof in its entirety and substituting the following in lieu thereof:

The name of the corporation shall be BankTrust of Florida, and its place of business, now known as its initial place of business, shall be 125 North Highway 71, Wewahitchka, Gulf County, Florida, 32465.

SECOND:

The foregoing amendment was adopted by the holder of all of the outstanding shares of common stock of the corporation, being the sole voting group entitled to vote on the amendment effected hereby, at the annual meeting of the sole shareholder of the corporation held on May 2, 2003, and the number of votes cast for said amendment was sufficient for approval by the holders of common stock.

The foregoing amendment shall be effective on the later of 12:01 a.m. on June 1, 2003 and the date and time it is filed with the Florida Secretary of State's Office.
