TO
ARTICLES OF INCORPORATION
OF

SANFORD-ORLANDO KENNEL CLUB INC., a corporation organized and existing under the laws of the State of Florida (the "Corporation"), hereby certifies as follows:

1. The name of the Corporation is Sanford-Orlando Kennel Club Inc. The date of filing of its original Articles of Incorporation with the Secretary of State of Florida was September 3, 1926.

2. Pursuant to and in accordance with Sections 607.1003, 607.1006, 607.0502 and 607.1508, Florida Statutes, these Articles of Amendment to Articles of Incorporation amend certain provisions of the Articles of Incorporation of the Corporation. These Articles of Amendment to Articles of Incorporation were authorized, approved and ratified by the Board of Directors and the Shareholders of the Corporation in accordance with Sections 607.0704 and 607.0821, respectively, of the Florida Business Corporation Act.

3. Article 1 is hereby amended to read as follows:

1. The name of the corporation is:
