**AMENDED AND RESTATED
ARTICLES OF INCORPORATION
OF
FREE PRESS PUBLISHING COMPANY, INC.**

Pursuant to Section 607.1006 and 607.1007 of the Florida Business Corporation Act, this Florida corporation adopts the following Amended and Restated Articles of Incorporation:

- A. The name of the corporation is: Free Press Publishing Company, Inc.
- B. These Amended and Restated Articles of Incorporation contain an amendment to the corporation's initial Articles of Incorporation requiring shareholder approval.
- C. The amendment was adopted and approved by the sole director and sole shareholder of the corporation by written consent on May 15, 2008.
- D. The corporation's initial Articles of Incorporation are amended and restated in their entirety and replaced with the following:

ARTICLE I. NAME

The name of the corporation is: Free Press Publishing Company.

ARTICLE II. PRINCIPAL OFFICE AND MAILING ADDRESS

The principal business office and mailing address of the corporation is 1010 West Cass Street, Tampa, Florida 33606.

ARTICLE III. BOARD OF DIRECTORS

The corporation shall have one (1) director. The number of directors may be either increased or diminished from time to time, as provided in the bylaws.

ARTICLE IV. CAPITAL STOCK

The number of shares of capital stock that the corporation is authorized to issue is 10,000 shares of common stock, having a par value of \$.01 per share.

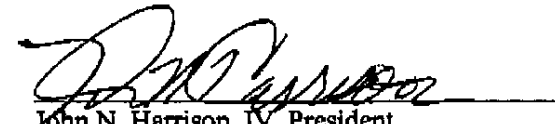
