### CHAPTER 14677—ACTS OF 1931 REQUIRING THE FILING OF THIS REPORT (AS AMENDED)

AN ACT Requiring Corporations Authorized to de Business in the State of Florida, Both Foreign and Domestic, Annually to File with the Secretary of State Certain Reports and to Pay a Certain Tax in the Nature of Filing Fee Thereon.

Section 1. All corporations, except such as are specifically exempted in Section 6 of this Act including those corporations heretofore incorporated under the laws of the State of Florida and those that may hereafter be incorporated under the laws of the State of Florida and all foreign corporations which heretofore have been or may fereafter be authorised to do business in the State of Florida, be and the same are hereby required to file with the Secretary of State on July 1st of each year a sworm report on such form as the Secretary of State shall prescribe, giving the names of the officers and directors and scribe, giving the names of the officers and directors and the Post Office address of each, the home office of the corporation, the name and address of the resident agent upon whom service of process may be made, the main into of business engaged in by the corporation, the date of the last meeting of its Board of Directors whether the corporation has been actively engaged in business during the previous twelve months or if its charter powers have been dormant and unused during that period, the number of the shares of the capital stock of such corporation with the per value thereof, the total amount of rapital stock and if a foreign corporation the amount of rapital stock and if a foreign corporation the amount of its capital stock and information as may be needed to show if the corporation is active or inactive, and such other information as may be needed to show in the State of Florida.

Section 2. Every corporation required to file reports as provided in Section 1 of this Act shall pay to the Secretary of State for the use of the State of Florida a filing fee or tax according to the schedule set forth in this action which, however, shall in ne instance be less than \$10.00 nor greater than \$1,000.00.

Section 2. The Secretary of State shall prescribe the form and furnish the bianks upon request to make the annual reports called for in this Act. It shall be the duty of the Secretary of State to examine the reports when received and if the information called for in this Act is given in such reports he shall file the same as information and keep such reports as peakle records. He shall pay into the State Treasury to be used for such purposes as the Legislature may determine all moneys cellected under the provisions of this Act. Such amounts for grinting form, postage, files, clerical and other expenses found to be actually necessary in carrying out the provisions of this Act is hereby appropriated from such funds not to exceed ten thousand deliars in any one year.

Section 6. The Secretary of State shall cause a notice of the requirements of this Act to be mailed to the last known address of every corporation doing business in the State of Florida which shall fail to file within thirty days after July first, the report called for herein and or pay the filing fee or tax herein imposed. Every corporation which shall fail to comply with the provisions of this Act within three months after July 1st of each year shall be deemed to be no longer exercising its charter or corporate privilege in this State.

Section 5. Any corporation failing to comply with the provisions of this Act for six months shall forfeit its corporate and charter privileges and shall not be permitted to maintain any action in any court in this State until such reports are filed and all fees due hereunder paid. On January first of each year the Secretary of State shall make up a list of the corporations of record in his shall make up a list of the corporations of record in his office which have failed to comply with the provisions of this Act and shall mail a copy of such lists to the Clerk of the Circuit Courts, and Civil Courts of Record, the Circuit Judges and the Justices of the Peace of this State.

Section 6. The following shall be exempt from the provisions of this Act: reitroad companies, Fullman companies, telephore and telegraph companies, bank and trust companies, building and loan associations, insurtures companies, co-operative marketing associations and once companies, co-operative marketing associations and corporations not for profit; these corporations and companies so exempt from the operation of this Act being panies so exempt from the operation either provisions of law.

Section 7. Nothing in this Act thall be construed as to apply to a corporation that has been adjudged bank-rupt or dissolved by order of the court, however, such rupt or a statement with the Secretary of State setting forth their status in this respect but shall not be required to pay a tax.

Section 8. The Secretary of State shall mail statement as required in Section 4 to corporations of record subject to the provisions of this Act, giving notice of the time in which reports must be filed; provided, however, in case of any Florida corporations having been organized less than twelve months griot to July 1st of any level in which reports are due to be filed and the tax year in which reports are due to be filed and the tax due to be paid and in case of any foreign corporation which has been authorized to de beziness in Florida for less than twelve months at the time the report is due to be made and the tax is due to be paid, then in that event, be made and the tax is due to be paid, then in that event, the tax due for that year shall be pro-rated according to the number of months the expression has been inegristence or authorized to de besiness in this State.

Section 9. All statements required to be filed under this Act shall be for the calendar year and where a corporation's fuscal year ends other than the calendar year it shall have ninety days after the ending of its fiscal year in which to file the statement as previded in this Act.

Section 10. Any clause or section of this Act which, for any reason, may be held or declared invalid may be eliminated and the remaining portions thereof shall be and remain in full force and be valid in the same manner and to the same extent as if such invalid clause of section had not been incorporated therein.

Section 11. Any corporation paying the maximum fee herein provided for shall not be required to file any reports whatsoever as required by the provisions of this Act.

Section 12. In the event the shares of stock of any such corporations should be no par value, then for the purpose of this Act, each share shall be deemed or presumed to have value of at least \$100.00 per share, which presumption may be overcome by actual proof submitted to the Secretary of State. For the purposes of this Act the Secretary of State is hereby authorized to make such investigation as he may consider necessary and to increase or decrease the value of ne par value stock as he may determine to be cerrect from the people abmitted.
