CERTIFICATE OF AMENDMENT OF CERTIFICATE OF INCORPORATION

The undersigned, G. W. Botts, and Thomas C. Duer, Chairman of the Board/Chief Executive Officer and Secretary, respectively, of Barnett Banks of Florida, Inc., a Florida corporation ("Corporation"), do hereby certify that:

- 1. At a meeting of the Board of Directors of the Corporation duly called and held on February 21, 1973, the Board of Directors approved the following amendment of paragraph (a) of Article Third of the Corporation's Certificate of Incorporation and proposed such amendment to the stockholders of the Corporation.
 - 2. A meeting of the stockholders of the Corporation was duly called and held on April 18, 1973, and at that meeting stockholders holding a majority of the stock entitled to vote thereon resolved that paragraph (a) of Article Third of the Corporation's Certificate of Incorporation be amended in its entirety to read as follows:

"ARTICLE THIRD: (a) The maximum number of shares of stock with nominal or par value which the Corporation is authorized to have outstanding at any time is Thirty-three Thousand (33,000) shares of preferred stock of the par value of Twenty Dollars (\$20) per share, amounting in the aggregate to Six Hundred Sixty Thousand Dollars

(\$660,000), and Twenty Million (20,000,000) shares of common stock of the par value of Two Dollars (\$2) per share, amounting in the aggregate to Forty Million Dollars (\$40,000,000)."
