Pursuant to section 607.224 of the Florida General Corporation Act, these Articles of Merger are adopted by Niceville Bankshares Corporation ("Miceville") and Barnett Banks of Florida, Inc. ("Barnett").

- Miceville, a Florida corporation, shall be merged into Barnett, a Florida corporation (the "Merger"). Barnett shall continue as the surviving corporation (the "surviving corporation") and the Amended and Restated Articles of Incorporation of Barnett shall be the Amended and Restated Articles of Incorporation of the surviving
- The merger shall be effective at 12:01 a.m. on August 1, 1985.
- The Plan and Agreement of Merger (the "Merger Agreement") was adopted by the directors of Niceville on April 10, 1985 and by the directors of Barnatt on April 17, 1985.
- An aggregate of 43,650 shares of Miceville's common stock are outstanding as the date hereof. On July 25, 1985, at a special meeting of shareholders, the Merger Agreement was approved, with 43,400 shares (99.4%) of common stock voted in favor of the agreement and no shares of common stock voted against it.
- pursuant to \$607.221(4), no vote of Barnett shareholders was 5.
- Notice of the special meeting and a Proxy Statement including the required. Merger Agreement was mailed to each of Niceville's shareholders on 6.
- On the Effective Date of the Merger, each outstanding share of Niceville common stock shall be cancelled and converted into the right to receive \$229.10 in cash.
