KNOW ALL MEN BY THESE PRESENTS that the undersigned, Guy N. Botts and Thomas C. Duer, as President and Secretary, respectively, of Barnett National Securities Corporation, a Florida corporation (hereinafter called the "Corporation"), do hereby certify that:

- 1. At a meeting of the Executive Committee of the Board of Directors of the Corporation duly called and held on August 13, 1969, resolutions were adopted by the Executive Committee declaring the Amendments to the Certificate of Incorporation hereinafter set forth to be advisable and recommending and proposing these Amendments to the stockholders of the Corporation.
- 2. A meeting of the stockholders of the Corporation was duly called and held on September 19, 1969, and at that meeting the following resolutions were duly adopted and are now in full force and effect:

WHEREAS, the Executive Committee of the Board of Directors of this Corporation at a meeting duly called and held has declared the following amendments to the Certificate of Incorporation of this Corporation to be advisable and has proposed these amendments to the stockholders for their approval; and
