# ARTICLES OF AMENDMENT OF ARTICLES OF INCORPORATION OF COASTAL TUG AND BARGE, INC.

Pursuant to Section 607.1066, Florida Statutes, COASTAL TUG AND BARGE, INC., a Florida profit corporation (the "Corporation") adopts the following amendment to its Articles of Incorporation.
