ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF LOGAN LUMBER COMPANY

1. The name of the corporation is LOGAN LUMBER COMPANY.

2. The text of the amendment adopted by the Board of Directors and and the shareholders is as follows: \Box
