This AGREEMENT AND PLAN OF MERGER adopted on December 1, 2004 by resolution of each Corporation's sole stockholder and the Board of Directors of National Boverages, Inc., a business corporation organized under the laws of the State of Florida, and adopted on by resolution of each Corporation's sole stockholder and the Board of Directors of Popol-Cola Matropolitan Bottling Company, Inc., a business corporation organized under the laws of the State of New Jerney.

The names of the corporations planning to merge are National Beverages, Inc., a business corporation organized under the laws of the State of Florida, and Pepsi-Cola Metropolitan Bottling Company, Inc., a business corporation organized under the laws of the State of New Jersey. The name of the surviving corporation into which National Beverages, Inc. plans to merge is Pepsi-Cola Metropolitan Bottling Company, Inc.

- National Beverages, Inc. and Pepsi-Cola Metropolitan Bottling Company, Inc., shall, pursuant to the provisions of the Florida Business Corporation Act and the provisions of the New Jersey Business Corporation Act. be merged with and into a single corporation, to wit, Pepsi-Cols Metropolitan Bottling Company, Inc., which shall be the surviving corporation upon the effective date of the mergar and which is sometimes hereinafter referred to as the "surviving corporation", and which shall continue to exist as said surviving corporation under its present name pursuant to the provisions of the laws of New Jersey. The directors and officers in office of Pepsi-Cole Metropolitan Bottling Company, Inc. upon effective date of the merger shall be the directors and officers of the surviving corporation, all of whom shall hold their directorships and offices until their respective successors have been elected and duly qualified.
- 5. All of the issued shares of the non-surviving corporation shall, upon the effective date of the merger, be surrendered and canceled and shall not be converted into shares of the surviving corporation. The issued shares of the surviving corporation shall not be converted in any manner, but each said share which has been issued as of the effective date of the merger shall continue to represent one issued share of the surviving corporation.
