For the above reasons, I ask that the \$400.00 penalty for filing after May 1, 2000 be abated and that the normal fee of \$150 be accepted by the Department of State.

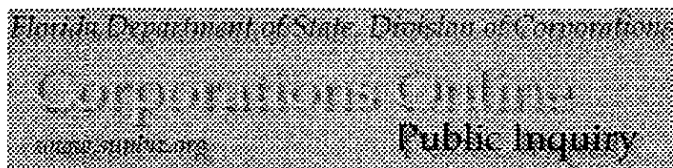
