Fraterial Benefit Societies and Corporations not for

profit.

It is only necessary to file this certificate within thirt, days after filing Certificate of Incorporation, as to domestic Corporation, and within thirty days after issuance of permit to foreign corporations; and thereafter only, when corporation has changed its place of business or agent.
