ARTICLES OF MERGER OF BECKER PROPERTIES, LLC INTO FLORIDA ROCK INDUSTRIES, INC.

In accordance with the provisions of Section 607.1109 of the Florida Business Corporation Act (the "Act"), Florida Rock Industries, Inc., a Florida corporation, does hereby deliver these Articles of Merger for the purpose of merging Becker Properties, LLC, a California limited liability company, with and into Florida Rock Industries, Inc. (the "Merger"), with Florida Rock Industries, Inc. being the surviving corporation in the Merger.

- 1. The Agreement and Plan of Merger (the "Plan") is attached hereto as Exhibit A.
- 2. The Plan was approved by Florida Rock Industries, Inc. in accordance with the applicable provisions of Chapter 607 of the Act.
- 3. The Plan was approved by Becker Properties, LLC in accordance with the applicable laws of the State of California.
- 4. The Merger shall become effective at 11:59 p.m., Eastern Daylight Time, on September 30, 2012.

AGREEMENT AND PLAN OF MERGER

of

BECKER PROPERTIES, LLC, a California limited liability company

into

FLORIDA ROCK INDUSTRIES, INC., a Florida corporation

September 21, 2012

Pursuant to Section 607.1108 of the Florida Business Corporation Act and Section 17551 of the California Corporations Code, Becker Properties, LLC, a California limited liability company, and Florida Rock Industries, Inc., a Florida corporation, hereby adopt the following Agreement and Plan of Merger as of the date first above written:

- 1. The names of the entities that are parties to the merger are Becker Properties, LLC, a California limited liability company ("Becker Properties"), the subsidiary company, and Florida Rock Industries, Inc., a Florida corporation ("Florida Rock"), the parent corporation. Pursuant to this Agreement and Plan of Merger, Becker Properties shall be merged into Florida Rock (the "Merger").
- 2. The name of the surviving entity is Florida Rock Industries, Inc., a Florida corporation.
- 3. Florida Rock is and will be a corporation organized and existing under the laws of the State of Florida. Immediately prior to the Merger, Florida Rock owns one hundred percent (100%) of the outstanding membership interest of Becker Properties.
- 4. The Merger shall become effective at 11:59 p.m., Eastern Daylight Time, on September 30, 2012 (the "Effective Time").
- 5. At the Effective Time of the Merger, the following shall occur:
 - (a) Florida Rock. By virtue of the Merger and without any action on the part of the holders thereof, the shares of common stock of Florida Rock then issued and outstanding will not be converted or altered in any mainer and will remain outstanding as shares of common stock of Florida Rock. Without limiting the foregoing, the sole shareholder of Florida Rock immediately before the Effective Time will have the same number of shares of common stock in Florida Rock immediately thereafter.
 - (b) <u>Becker Properties.</u> By virtue of the Merger and without any action on the part of the holder thereof, the membership interests of Becker Properties

held at the Effective Time of the Merger shall be cancelled, and noconsideration (in the form of shares of common stock in Florida Rock or otherwise) shall be paid therefor.

- 6. The street address of Florida Rock's principal place of business is and will be 1200 Urban Center Drive, Birmingham, Alabama 35242.
- This Agreement and Plan of Merger shall be binding upon, and inure to the benefit of, the parties hereto and their respective successors and assigns. This Agreement and Plan of Merger may be executed simultaneously in two or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument. This Agreement and Plan of Merger, including the other documents referred to herein, contains the entire understanding of the parties with respect to the subject matter hereof.
