Pursuant to the provisions of section 607.1006, Florida Statutes, this Florida profit corporation adopts the following Articles of Amendment to its Articles of Incorporation, filed on the 13th day of October, 1945:

FIRST: The following amendment of the Articles of Incorporation was adopted by the corporation:

Change of Name:

From: Alcoma Packing Company, Inc.

To: U & H Caretaking, Inc.

SECOND: The amendment was adopted by the Board of Directors on the 19th day of August, 1997.

THIRD: The amendment was approved by the shareholders of the corporation at a special stockholders meeting on the 19th day of August, 1997, to become effective on September 1, 1997. The number of votes cast for the amendment was sufficient for approval.

FOURTH: Following the amendment to the charter and upon surrender of each share of stock bearing the superseded name of the corporation, each shareholder shall be issued one share of stock for each share of stock so surrendered bearing the new name of the corporation.
