**AMENDED AND RESTATED ARTICLES OF INCORPORATION
OF
GABLES ENGINEERING, INC.**

GABLES ENGINEERING, INC., a Florida corporation (the "**Corporation**"), hereby amends and restates its Articles of Incorporation, as amended from time to time, in their entirety as follows.

ARTICLE I: NAME

The name of the corporation shall be Gables Engineering, Inc. (the "**Corporation**").

ARTICLE II: PRINCIPAL OFFICE

The street and mailing address of the principal office of the Corporation is 247 Greco Avenue, Coral Gables, Florida 33416.

ARTICLE III: SHARES

The total number of shares that the Corporation is authorized to issue and have outstanding at any time is 500,000, all of which shall be common stock.

ARTICLE IV: REGISTERED OFFICE AND AGENT

The street address of the registered office of the Corporation is 301 Arthur Godfrey Road Penthouse, Miami Beach, Florida 33410. The name of the registered agent of the Corporation at that office is Loren H. Cohen of Mitrani, Rynor, Adamsky & Toland, P.A.

ARTICLE V: INDEMNIFICATION OF DIRECTORS AND OFFICERS

The Corporation shall indemnify, advance expenses, and hold harmless, to the fullest extent permitted by the Florida Business Corporation Act and other applicable law as it presently exists or may hereafter be amended, any person (a "**Covered Person**") who was or is made or is threatened to be made a party or is otherwise involved in any action, suit, or proceeding, whether civil, criminal, administrative, or investigative, and whether formal or informal (a "**Proceeding**"), by reason of the fact that he or she, or a person for whom he or she is the legal

representative, is or was a director or officer of the Corporation or, while a director or officer of the Corporation, is or was serving at the request of the Corporation as a director, officer, employee, or agent of another corporation or of a partnership, joint venture, trust, enterprise, or nonprofit entity, including service with respect to employee benefit plans, against all liability, damages, and loss suffered and expenses (including attorneys' fees) actually and reasonably incurred by such Covered Person. Any amendment, repeal, or modification of this Article V shall not adversely affect any right or protection hereunder of any person in respect of any act or omission occurring prior to the time of such repeal or modification.

These Amended and Restated Articles of Incorporation were approved by Written Consent of Directors and Shareholders as of June 30th, 2020, and such approval was sufficient to
