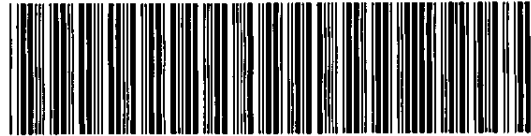

The undersigned, for the purpose of amending the Articles of Incorporation of J.C. RENFROE & SONS, INC. (the "Corporation") pursuant to §607.1006 of the Florida Statutes, hereby makes, acknowledges, and files this Amendment to the Articles of Incorporation of J.C. RENFROE & SONS, INC. The original Articles of Incorporation were filed with the Florida Department of State on March 9, 1949. The Amendment is set forth as follows:

1. The name of this Company is J.C. RENFROE & SONS, INC.
2. The Articles of Incorporation of J.C. RENFROE & SONS, INC. have been amended by deleting Article I in its entirety and by substituting in lieu thereof the following Article:

"Article I - NAME

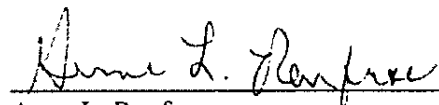
The name of this corporation shall be:
