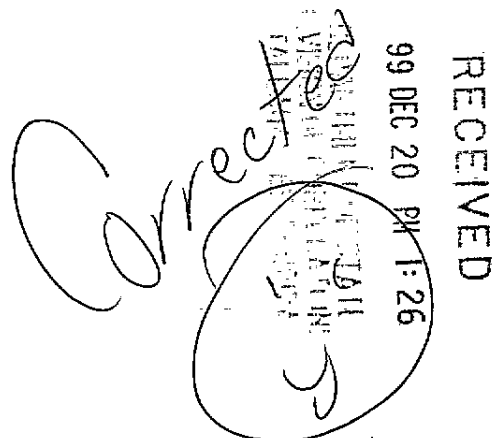

The name of the corporation is: PLP of Lake Placid, Inc.


3. The effective date of this amendment shall be as of the close of business on the 21st day of December, 1999.
