TO CORPORATION ADDRESSED: This is a new form for filing your corporation capital stock tax. The form is designed so if you desire you may make a duplicate copy for your file. Tear apart at the perforated fold and keep COPY for your file, return ORIGINAL with tax due to the Office of Secretary of State, Tallahassee, Florida.

Corporation Capital Stock Tax is due July 1 each year. If stock is 'no par value', show the number of outstanding shares including any paid in surplus and any surplus set aside as part of the invested capital and include a brief financial statement.

For capital stock of over \$50,000.00 and not over \$100,000.00	75.00
For capital stock of over \$100,000.00 and not over \$200,000.00	100.00
For capital stock of over \$200,000.00 and not over \$500,000.00	200.00
For capital stock of over \$500,000.00 and not over \$1,000,000.00	500.00
For capital stock of over \$1,000,000.00 and not over \$2,000,000.00	750.00
For capital stock of over \$2,000,000.00	1,000.00

The capital stock above mentioned refers to the invested capital represented by shares of stock outstanding.

(2) In the case of any Florida corporation having been organized or any foreign corporation which has been authorized to do business in Florida, less than twelve (12) months at the time the report is due and the capital stock tax is to be paid, the tax due that year shall be pro rated according to the number of months the corporation has been in existence or authorized to do business in this state.

(4) In the event any of the shares of stock of any such corporation should be of no par value, then for the purposes of this section, each share shall be presumed to have value of at least one hundred dollars (\$100.00) per share, which presumption may be overcome by actual proof submitted to the secretary of state. The secretary of state shall make such investigation as he may consider necessary and increase or decrease the value of no par value stock as he may determine to be correct; and in so doing he may take into consideration all facts tending to show the fair market value of the stock, including its sale price, the amount of the surplus of the corporation and such other pertinent facts as he may deem advisable.

608.35 Penalty for failure to file report and pay tax.—Any corporation failing to comply with the provisions of §1008.32 and 608.33 for six (6) months shall not be permitted to maintain or defend any action in any court of this state until such reports are filed and all taxes due under this chapter be paid.

EXCERPTS FROM CORPORATION CAPITAL STOCK TAX LAW

608.33 Capital stock tax.—

(1) Every corporation, except railroad, pullman, telephone, telegraph, insurance, banking and trust companies, building and loan associations, cooperative marketing associations and corporations not for profit, doing business in this state shall pay to the state for the use of the state a capital stock tax according to the following schedule:

For capital stock of over \$10,000.0 and not over \$25,000.00	25.00
For capital stock of over \$25,000.00 and not over \$50,000.00	50.00
