AGREEMENT AND PLAN OF MERGER

THIS AGREEMENT AND PLAN OF MERGER (the "Plan") dated as of December 30, 2013 provides for the merger (the "Merger") of FLAT GLASS DISTRIBUTORS, LLC, a Florida limited liability company, LEE & CATES FLORIDA GLASS, LLC, a Florida limited liability company, LEE & CATES GEORGIA GLASS, LLC, a Florida limited liability company, LEE & CATES RESIDENTIAL GLASS, LLC, a Florida limited liability company, and LEE & CATES SUPPORT SERVICES, LLC, a Florida limited liability company ("Merging Companies") with and into LEE & CATES GLASS, INC., a Florida corporation (the "Surviving Corporation"), as follows:

WITNESSETH:

WHEREAS, the Merging Companies are limited liability companies organized and existing under the laws of the State of Florida;

WHEREAS, the Surviving Corporation is a corporation organized and existing under the laws of the State of Florida;

WHEREAS, Section 607.1108 of the Florida Business Corporation Act permits another business entity to be merged into a corporation;

WHEREAS, Section 608.438 of the Florida Limited Liability Company Act permits a limited liability company to be merged into another business entity; and

WHEREAS, the Members of the Merging Companies have deemed it to be in their best interests for the Merging Companies to merge into the Surviving Corporation.

NOW, THEREFORE, the Merging Companies hereby agree that the Merging Companies shall be merged into the Surviving Corporation in accordance with the applicable laws of the State of Florida and the terms and conditions of and in the manner set forth in this Plan of Merger.

- Time, all of the Member Interests in the Merging Companies which are issued and outstanding at the Effective Time shall be retired and cancelled, automatically, without any further action on the part of Merging Companies or the Surviving Corporation, or otherwise. Thomas D. Lee, III ("Lee") owns an unvested one percent (1%) profits interest in each of the Merging Companies which was granted pursuant to Restricted Units Agreements entered into with each of the Merging Companies in December 2010. By signing below, Lee understands, acknowledges and agrees that his one percent (1%) member interest in each of the Merging Companies will be extinguished in the mergers and he will receive no consideration therefore. Lee waives any and all dissenters rights, appraisal rights or similar rights in connection with the mergers.
