Notification has been received that the subject Corporations have been dissolved due to lack of annual fee payment. I would like to have them reinstated and have visited with your office and was informed that if I sent \$150 for each entity that it would be put under consideration. The checks are enclosed.

The Sea Bee Corporation has used Ms Lucille Fasse as the Registered Agent in Crestview, FL. She has been in failing health and we will have to get a new agent to replace her. It is my understanding that your office did have the first notice returned, however we did receive the 2nd notice and the dissolution notice (both forwarded by Ms Fasse).

Two Lakes Corporation has used Mr. Dale Rice, Attorney, as the Registered Agent in Crestview, FL. He did not send us the first notice, but did send the second notice. If he received the dissolution notice, it has not been forwarded to me.

I talked with Mr Rice in August and told him about the situation with both Corporations and he advised me to send him all the paper work, two sets of checks, one set for the \$150 fee and the other set for \$550 made payable to The State of Florida, and he would see what he could do for us. This was done on Aug 12, 2000. When the deadline approached in September, I gave him a call and he hadn't gotten to it yet. Since that time I have left messages with his secretary and on his answering machine to no avail.

Please review the above situation and hopefully you will accept my checks for \$150 each. I suppose it is possible that Mr Rice has sent the checks to you for these delinquencies, and I am sure you will verify that. I am sorry that this happened and do appreciate your efforts to help us.

I want to obtain a new registered agent for both corporations, and have future mailings come directly to the above address. Please advise me on my next step to take.
