## ARTICLES OF AMENDMENT ARTICLES OF INCORPORATION J. ED. ABERCROMBIE INSURANCE AGENCY, INC.

- 1. The name of this corporation is J. ED. ABERCROMBIE INSURANCE AGENCY, INC.
- Articles of Amendment to the Articles of Incorporation of J. ED. ABERCROMBIE INSURANCE AGENCY, INC. were duly and unanimously adopted by the shareholders of J. ED.ABERCROMBIE INSURANCE AGENCY, INC. on April //, 2011.
  - 3. The amendments so adopted were:
- a) to amend Article I of the Articles of Incorporation of J. ED.ABERCROMIBE INSURANCE AGENCY, INC. to change the corporate name to ABERCROMBIE INSURANCE AGENCY, INC. so that Article I shall read in its entirety upon such amendment, as follows:

#### "ARTICLE I
