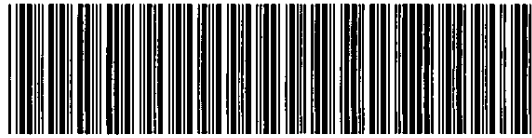

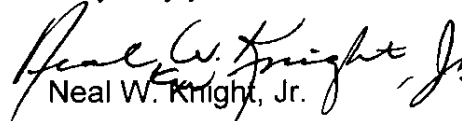

The Articles of Incorporation of Robert W. Gottfried, Inc are amended and restated as follows:

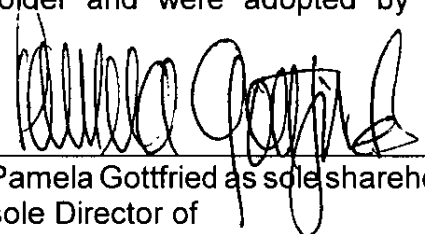
The name of this corporation is Robert W. Gottfried, Inc.
