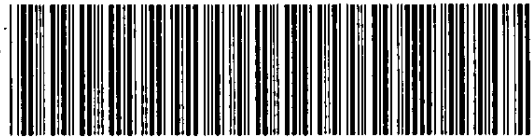

Article I - Name
