Your SECOND NOTICE for my Corporation Annual Report was just received. However, since I had not received a FIRST NOTICE I contacted your office at 488-9000. I was instructed to write this letter to the above address, enclose my Annual Report with a check for \$150.00 and explain the situation.

Our sole operation over the past eighteen years has been the development of a 535 acre rural residential retirement community called "THE FARMS AT QUINCY". Since my office and home were very close, I used the same address for both with one rural mailbox. The official address was Route 2, Box 245, Quincy, FL. 32351. The 33 Planters Circle address was an anticipated 911 address.

Two things happened since the first of the year. First, we sold our old home and moved to another location within the development. Second, the corrected 911 numbers were assigned to the old and the new homes as well as the corporation office. The old address stayed with our old home and is the address of the new owners. Our new residential address is now 95 Magnolia Glen, still within the development but about a mile from the corporate office. The corrected 911 address for the office is now 24 Planters Circle.
