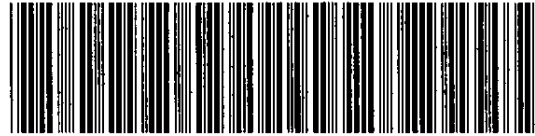

Pursuant to the provisions of Section 607.1006, *Florida Statutes*, this Florida profit corporation adopts the following amendment to its Articles of Incorporation:

NEW CORPORATE NAME
