ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF ON TOP OF THE WORLD, INC. (a Florida Corporation)



Pursuant to the provisions of Sections 607.1006, Florida Statutes, this Corporation adopts the following articles of amendment to its Articles of Incorporation:

- 1. The name of the Corporation is: **ON TOP OF THE WORLD, INC.** (the "Corporation").
- 2 Article I of the Articles of Incorporation is amended to read in its entirety as follows:

"Article I - Name

The name of the corporation is changed from ON TOP OF THE WORLD, INC. To ON TOP OF THE WORLD COMMUNITIES, INC."

3. The foregoing amendment was adopted by a joint written action of the board of directors and the shareholders of the Corporation as of the $\cancel{\cancel{9}}$ day of December, 2002. The number of votes cast for the amendment by the shareholders was sufficient for approval.
