Secretary of State (the "Secretary"), and finds that the relief sought by Plaintiffs should be granted.


IT IS THEREFORE ORDERED AND ADJUDGED that KATHERINE HARRIS in her capacity as the Florida Secretary of State shall:

1. set aside the merger merging Boone (K98891) and Englewood (P97000024419), into Waste Management, Inc. of Florida on 12/29/98;

2. set aside the merger merging Harris (327888) into Waste Management, Inc. of Florida on 12/29/98; and

3. amend the merger merging Gulf (282147), Charlotte (204287), and Waste Management of Orlando, Inc. (240165) into Waste Management, Inc., of Florida on 12/29/98, to the extent that Gulf and Charlotte are deleted from this merger.
