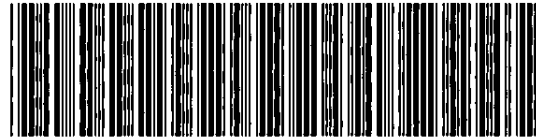

ARTICLES OF AMENDMENT TO
CHARTER OF
THE CITIZENS BANK OF PERRY

Pursuant to Section 607.1006, Florida Statutes, the Charter, which constitutes the Articles of Incorporation, of The Citizens Bank of Perry, a Florida banking corporation, is hereby amended as follows:

FIRST:

Article # I of the Charter is hereby amended by deleting the text thereof in its entirety and substituting the following in lieu thereof:

The name of the corporation shall be CITIZENS STATE BANK,
and its place of business, now known as its initial place of
business, shall be 2000 S BYRON BUTLER PARKWAY,
PERRY, TAYLOR COUNTY, FLORIDA, 32348-5512.

SECOND:

A board meeting of the corporation was held on February 8, 2007, and the number of votes cast by the board of directors for said amendment was unanimous and sufficient for approval, pursuant to Section 607.1002, (6), Florida Statutes. Shareholder approval is not required.

THIRD:

The foregoing amendment shall be effective on the later of 12:01 a.m. on May 1, 2007 and the date and time it is filed with the Florida Secretary of State's Office.

IN WITNESS WHEREOF, the undersigned has caused the Articles of Amendment to the Charter of The CITIZENS BANK OF PERRY to be executed and attested to by its duly authorized officers as of the 13th day of February, 2007.
