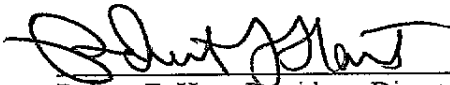

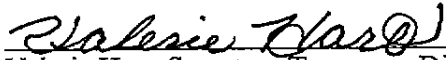
The undersigned, ROBERT F. HART and VALERIE HART, pursuant to Florida Statutes, files these Articles of Dissolution and states:
