ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF <u>EPICURE MARKET, INC.</u>

Pursuant to the provisions of Section 607.1006 of the Florida Business Comporation Act (the "Act"), the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

- 1. The name of the corporation is EPICURE MARKET, INC. (the "Corporation"), Charter # 215713, filed on September 24, 1958.
- 2. The following Amendment to the Articles of Incorporation was adopted by the all of the Directors of the Corporation and by all of the Shareholders of the Corporation, the number of votes cast being sufficient for approval, on April 1, 1998 in the manner prescribed by Section 607.1003 of the Act:

RESOLVED, that Article I of the Corporation's Articles of Incorporation shall be amended in its entirety to read as follows:

ARTICLE I

<u>Name</u>

The name of the Corporation is MaH Alton Road Corp. (hereinafter called the "Corporation")

3. Except as hereby amended, the Articles of Incorporation of the Corporation shall remain the same.
