1. Pursuant to Section 607.1006 of the Florida Business Corporation Act, Article I of the Articles of Incorporation of AIRGUIDE CORPORATION, a Florida profit corporation (the "Corporation") is hereby amended to read as follows:

ARTICLE I

The name of the corporation is AGVent Corporation.

2. Except as hereby amended, the Articles of Incorporation of the Corporation shall remain the same.
3. These Articles of Amendment shall be effective upon filing with the Florida Department of State.
4. The foregoing amendment to the Articles of Incorporation of the Corporation was adopted by the Joint Unanimous Written Consent of the Sole Shareholder and Board of Directors of the Corporation, and the number of votes cast was sufficient for approval.
