The undersigned subscribers to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation under the laws of the State of Florida.

### ARTICLE I.

The name of this corporation is: SECURITY SERVICES CORP

# ARTICLE II.

The general nature of the business to be transacted by this corpcration is: To engage in every aspect and phase of the business of conducting and providing guard and protective services.

### ARTICLE III.

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is: Five Thousand (5,000) shares with a nominal or par value of One (\$1.00) Dollar per share.

# - ARTICLE IV.

The initial post office address of the principal office of this corporation in the State of Florida is 811 Ainsley Building, Miami 32, Florida. The Board of Directors may from time to time move the principal office to any other address in Florida.

## ARTICLE V.

This corporation is to exist perpetually.
