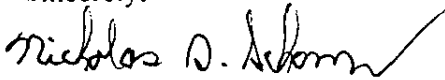

FOURTH: The name of its present registered agent is Thomas L. Schommer, which shall remain the same.

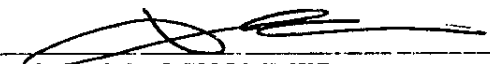
